

#### Introduction

Family is the social unit that any person gets membership initially by his or her birth. A collection of families forms society.

As a member of the family, from your childhood you develop good habits which will be quite helpful in future to live as a good citizen. You should determine to work with dedication facing the challenges in life successfully and achieving effective objectives in life.

By studying this lesson unit well, you as a member of a family, will get the opportunity of developing social skills which are essential for you to lead a good social life.

The society that we live in is a collection of a number of family units. Family is the smallest social unit in a society. A person becomes a member of a family by birth. In the same manner, a person spends his whole life as a member of the family.

In relation to various other social institutions that prevail in the society, the family consists of a few members. In addition to that, the family bonds are very strong among the members of a family. Close interpersonal relationships bind the family members with one another. Members of a family help each other all the time in order to fulfill their various needs. They act for the betterment of their family members.

Family units that exist in the modern society can be classified on the basis of their members as:

- Nuclear family
- Extended family

#### **Nuclear Family**

Think of the members of your family. It can be a family unit formed by mother, father and children. Nuclear family is a family which consists only of the mother, father and children living in the same residence.

#### **Extended Family**

The family which consists of mother, father, children and some paternal or maternal relatives living together in the same residence is known as an extended family. In our society, We can see this type of families. Perhaps, yours may also be one such family.

An extended family is a unit of family, which consists of a group of relatives belonging to three or more generations.

Significance of an extended family in relation to a nuclear family

- The strength of the family is greater as there are more members in the family.
- Convenience in obtaining labour for routine household chores or economic activities.
- Children receive love, protection and affection, not only from their parents, but from the other members of the family as well.

- Adult members of the family receive love, protection, affection and support from other members of the family.
- Younger generation from childhood becomes familiar with the better qualities like treating the adults well, respecting them, helping and supporting them.
- Convenience in transferring culture to the younger generation.
- Since responsibilities are shared among the members, family affairs could be easily and conveniently fulfilled.

- The responsibility of looking after the children is shared among the members of the family.
- Ability to build up broader relationships with the external society.

Members obtain the opportunity of enjoying the above benefits as a member of an extended family. However, in the modern society, it is a common fact that due to the effects of socio-economic factors like parents engaged in employment in distant places, the families with insufficient home space are compelled to organize themselves into nuclear families instead of extended families.

Nevertheless, even the members of nuclear families perform functions like maintaining relationships with grandparents and other relatives, working in collaboration with them and looking after them all the time. Such acts contribute towards the well-being of both the members of the family as well as the entire society.


#### Common features that can be seen in a family

When we consider the composition, performance and the existence of a family, we can observe several significant features of a family unit. Some of them are given below.

- Build up on the basis of kinship
- A nuclear family consists of a few members while the extended family consists of several members
- Members live in one home
- Members maintain close relationship
- The resources of the family are distributed among the members on a fair basis
- Influencing each other for the well-being of the family
- Acting for the benefit of all members of the family
- Maintaining closer relationship among the members on the basis of qualities like love, kindness, affection and compassion

Stability, strength and good quality of the family units become the foundation of a qualitatively stable society.

- ★ Obtaining the help of the teachers and peers on these subjects
- ★ Engaging in subject related exercises regularly
- ★ Spending leisure meaningfully

If you follow these procedures well you will get the opportunity of passing the examination well. Maintaining this objective throughout your school life is a way of getting access to higher education. Through this, you will be able to achieve the expected objectives in your life.

#### Selecting suitable objectives

#### **Palm Prints**




Figure 1.5 - Palm Prints




Figure 1.14 - Students playing a game




Figure 1.18 - Children in a picnic with parents




Figure 1.20 - Sad

Inability to control and manage unfavourable emotions, harmfully affects a person's mental and physical health. On some occasions if a person cannot fulfill his intentions and expectations in the same way as he wishes, emotions like

sadness and sorrow may be generated in the mind. Failure or inability to gain higher examination results should not create an emotional state of losing hope about life. Sitting for the examination again or determining to engage in educational activities with much interest will help to fulfill the intentions.

Giving way to unwholesome emotions such as, sudden anger and motive to take revenge, harmfully affects the person himself as well as the well-being of society. You may have witnessed such incidents through media.

Therefore, management and control of emotions in a favourable manner should become a habit in life.

Passing an examination, winning a competition and birth day are several occasions that make you happy and you express your happiness. On such occasions express your happiness meaningfully so that it makes another person happy.

As a consumer it is very important to be cautious about market conditions. 


Figure 1.25 - Label of a product

Based on the service conditions there are workers paid on a daily, weekly or monthly basis. In certain situations the payment for the service is given once they complete the assigned work.

Either your father, mother or sometimes both of them may be engaged in occupations associated with the world of work. A large portion of their earnings is spent on purchasing goods and services essential to fulfill the needs of family members. It is quite essential to engage in a legitimate occupation to earn a sufficient income for the survival and progress of the family.

# Benefits of earning a sufficient income through employment

- Ability to fulfill daily needs of the family
- Get the opportunity to consume a sufficient amount of goods and services for the members of the family to fulfill their needs
- Ability to maintain a good living condition
- Ability to save a part of the income for the use in case of an emergency

If the occupation of the parents is lost due to some reason it will affect all the members of the family unfavourably.

As the family does not get a sufficient income the family faces the problem of fulfillment of basic needs like food, clothing, shelter, education and health. Lack of sufficient income basically leads to the downfall of the living conditions of the family.

When parents are engaged in occupations sometimes they have to leave home for distant places for their employment. It is also common now for some parents to leave the motherland for employment abroad. Due to these factors modern family units are subject to various challenges. Some of these situations are given below.

- Members of the family lose the protection of their parents
- Children are denied of the proper enjoyment of love and affection of their parents
- Seeking support from external people for the protection of the family members

As a member of the family you should be able to understand these challenges properly. You should also develop strength and ability

to face these challenges successfully. Ensuring the protection of family members and following the advice given by parents, elders and teachers are some effective strategies that can be followed to overcome these challenges successfully.

Association with relatives is immensely beneficial to pass down these practices to the younger generation. Relatives participate in various functions of the family. Religious activities held at home, weddings, housewarming ceremonies are examples of some such functions.

These opportunities of meeting relatives generate happiness and pleasure among members of the family.

Participation of all the members of the family at funerals is a commendable feature. When a relative of a family passes away, it is a social tradition followed by the close relatives to gather together to pay last respect to the deceased.

Lullabies and local folk songs also have attempted to generate love, respect, bond in the small children towards family members.

# Customs, and traditions practised in the family

#### **Customs**

There are customs and traditions connected with various matters of the family. They are followed in different occasions in the life of the family members. Customs guide us on those that we should do and avoid. Knowledge about the customs followed at the following occasions are important. They are:

- Laying the foundation stone for a new house
- Housewarming ceremony
- Introduction to the letters of the alphabet (Akuru Kiyaweema) ceremony
- Weaning ceremony (Idul Kata gaema)
- Wedding ceremonies
- Customs followed at funerals

Sri Lanka is a multi-cultural country. It consists of various communities, followers of various religions, users of different languages. Therefore, they follow different customs and traditions and sometimes there are also regional differences in these practices.

# Traditions prevailing in the family

Customs and rituals that prevailed in society for a long time can be considered as traditions. Sometimes there may be traditions confined to your family alone. Instances of such traditions maintained by the family are given below:

- Daily religious observances
- Worshiping parents and elders before leaving home
- Taking meals together with other family members
- Visiting relatives before the dawning of the New Year (in some regions this is practised after the dawn of New Year)
- Going to religious places together with the members of the family on days of religious importance.

You should be well aware of the traditions followed by members of the family. You should vehemently follow and practise these traditions. Upholding the traditions followed by adults further contributes to the well being of the family as well as the society.

# Relationships maintained between the family and the neighbours

It is quite difficult for a person or a family to fulfill one's needs and requirements alone. On various occasions, we have to seek the help and support of our neighbours. In the same way there are many occasions in which our neighbours, too, seek our help and support. From time immemorial, it has been a specific feature of the few oriental culture to build up cordial relationships with neighbours. Think of occasions on which your neighbours come to help your family. The help you got from your neighbours at various activities of the family, emergency situations, and at ceremonial functions may have become very important for your family. Working cordially with neighbours is also important for all of us as members of society.

Following are examples of some such occasions.

- Shramadana activities
- Common religious activities
- Occasions of tiling roofs
- Site preparation for the construction of a house
- Supply of refreshments at funerals
- Preparing land for paddy cultivation(preparing ground / reaping paddy)

Working in collaboration with neighbours helps the development of the region that you live in. Unity among the people living in an area immensely contributes to carry out various community activities effectively.

If we want to develop a cordial relationship with neighbours, we should be very much concerned about carrying the routine activities of the family without disturbing their community life. Improper disposal of waste material, the use of televisions and radios at a high volume, engagement of unlawful occupations are some examples that disturb the community life. We should always take precautions to avoid the occurrence of such situations. It is also our social responsibility to build up our pattern of living in such a way that it contributes to the well being of the society.

## Introduction

Family is the smallest unit in a society. Any society is created on the basis of a family. A nuclear family consists of mother, father and children while an extended family consists of other relatives in addition to them. If man spent a lonely isolated life, a society of this nature would never have emerged.

Spending a collective life with cooperation is an outstanding feature of human beings.

Society therefore is a creation of man, with man as the base. It is human nature that working collectively and the preference to be in groups. The existence of society is the result of man starting to lead a life of morality.

For example, people of hunting era had spent a collective life and worked in cooperation to fulfill their food requirements and their basic needs.




Figure 2.2 - A picture of hunting era

With the development of agricultural activities, the need for preparing lands, cultivating, harvesting, exchanging goods, and other services became complex. There they worked more with social groups and institutions. Therefore it could be noticed that development took place as an agrarian peasant society. Society became more complex with the enhancement of industrial knowledge and the skills of making and using goods. It was expanded further on the basis of producing goods, extracting resources, trade and consumption. With the modern technological era, this situation has become more complex.



## **Inter-relationships in the society**

A human society exists or becomes successful, only if it has good inter-relationships. This inter-relationship should be there between mother and father, while the same kind of relationship should be maintained among children and relatives too. Whenever the relationship within the family is strong, inter-family relationships will also be strengthened. Thus when a strong relationship is built among the families, the whole society becomes inter connected with strong bonds

Accordingly, the inter relationships in a human society can be indicated as follows:

# Inter-relationship with neighbours



Figure 2.10 - Shramadhana


# Maintaining inter-relationship with social institutions

- Can I give new solutions for practical problems?


If you have positive answers for these questions, you are truly a creative person. Then you can face any challenge successfully.

## **Rights of professionals**

Article 23 of universal charter on human rights has given every individual the right to work, right to choose one's occupation freely, right to enjoy reasonable facilities while working and to ensure job security.

Accordingly, several rules and regulations have been introduced to safeguard rights of servants in public as well as in private sectors.

- Safeguarding the rights of people through the constitution.
- Several provisions such as labour laws, employee's provident fund, widows and orphans pension, insurance schemes, human rights commission and establishment code, have been introduced to safeguard the rights of professionals.
- Accordingly, any person who faces an injustice in the place where he or she is employed, of these rules and regulations will safeguard them.

## Disadvantages of not practising employee's laws correctly

- Exploitation of labour
- Dissatisfaction of employees
- Not getting a reasonable salary
- Loss of job security
- Being helpless after the retirement
- Injustice caused to workers
- Being subject to the influence of employers
- Accidents and diseases caused by insecurity

## Preventing exploitation of child labour

According to Shop and Office Employees Act, made against exploitation of child labour, children below the age of 14 cannot be employed. If such children are employed, it can be prevented by informing the Commissioner of Labour.

Since education is compulsory in Sri Lanka, every child under the age of 14 should attend school. Children are employed mainly due to economic problems in families, helplessness of children, ignorance of parents, influences of some people, and traditional occupations.

## Impacts of employing children as labourers

- Falling ill as physical and mental strength weaken
- Exploitation of labour

- Subject to abuse
- Losing opportunities for learning
- Losing the pleasant childhood
- Engaging in anti-social activities
- Addiction to intoxicated drugs
- Subject to harassments
- Getting mental / physical disorders

- Directing them to a school for compulsory education
- Not employing children for narrow expectations
- Making the relevant institution aware of child labour
- Adults not depending on children

#### **Retirement of servants**

All the employees in both public and private sectors have a legal procedure for retirement. Government servants are to retire at the age of 57 but they have the option to work until the age of 60. Private

sector servants can get their Employees Provident Fund at the age of 55. However the female employees can get it for their marriage.

Before retirement, the servants should make the Department of Pension, aware of their retirement through the heads of institutions they are employed in. Prior to retirement they should submit all the relevant documents and complete their files.

## Spending the retirement fruitfully

Both public and private sector servants spend their time and labour on behalf of the needs of the people in the country. Once they lose the usual duty – bounded environment, in which they worked for a long period of time, they are liable to face physical and mental inconveniences.

Therefore it is important to work with a pre-plan to spend one's retirement productively. They can engage in different types of activities such as engaging in hobbies, helping for family affairs, engaging in creative activities, and sharing their own experiences.

## Financial rights for the duties performed


Every employee is legally entitled to get a salary and some of them are entitled to get over time allowances for extra work done in their extra time. Since you are given a salary for your service in an institution, it is the duty of every servant to do a service in par with the salary they obtain.

## **Inspiring story of Wilma Rudolph**

Wilma was born in Natshwill hospital in the Untied States of America. She was suffering from Double Pneumonia, and scarlet fever. Her left leg was affected by polio. She was crippled. Her legs had to be supported with leg braces. It was annoying for her. Wilma strongly believed that she would be able to remove leg braces at the age of eleven. She engaged herself excessively in exercises with self-confidence disregarding medical advice and without the knowledge of her mother. After that, she removed her leg braces herself. By the age of 12 she understood that she could run, jump and engage in sports like an ordinary child. Then she did her sports with great dedication. She won a bronze medal in Olympics held in Melbourne in 1956. There, she made a strong determination to win a gold medal in the Olympics to be held in 1960. Since she was weak in education, her family did not allow her to engage in extra-curricular activities. Therefore she went away from home creeping through the chimney and engaged in sports practices secretly from 8.00 p.m. –10.00 p.m. with a great determination and dedication.

She participated in the 1960 Olympics amidst huge applaud of the crowd. She had a clear vision of winning the gold medal before participating. Accordingly, she became the first American woman to win three gold medals in 100, 200 and 400 metre running events holding world records. This Wilma who was a crippled girl in her childhood became undefeatable with the support of her parents, and the assistance of a few family friends.

Story of Wilma is a fine example for the possibility of winning any challenge by working with great self confidence and dedication.

## Obligations and responsibilities to be fulfilled for the well being of society

## **Obligations**

Obligations are those which people are bound to do as citizens for the existence of common society. These obligations can be divided into two as legal and moral.

We are legally bound to fulfill legal obligations. If we neglect them we are liable to be punished. Therefore for the well being of society the responsibility of all citizens should not ignore legal duties.

Moral obligations are not legally bound and they are related to the conscience of a person. Even though we do not fulfill these obligations we will not be subject to any punishment. But we will be blamed and rejected by the society. Society can either give punishments or not.

However, by failing fulfilling these moral obligations with the lapse of time one will be subject to mental conditions like sadness, being fed up, unrest and inconvenience, causing deterioration of personal life style. For example, parents look after their children by feeding, giving education, moulding their future and bestowing their own properties. If the children do not look after parents in return, it is a negligence of obligations. It will deteriorate the person.

Therefore, both legal and moral obligations are essential for the smooth existence of society.

The liability to fulfill obligations is known as responsibility. As members of a society we have many responsibilities to fulfill.


## Example -

## Introduction

Sri Lankan society is multi cultural in nature having different ethnic, language and religious groups. Specific cultural features of each ethnic and religious groups can also be identified. There are also some cultural features common to all these ethnic and religious groups. This unit develops the competencies and skills necessary for a Sri Lankan citizen, who identifies cultural similarities and differences, ensures peace, co-existence and social integrity.

## **Identifying Culture**

Every society has a culture which is specific to it. Aggregation of behavioural patterns, habits, customs, rituals, attitudes and beliefs of people in any society is culture.

Culture includes the way people live in a social system, too. Different people have explained the word culture in various ways. Therefore a precise definition cannot be presented.

We all have a culture. The aggregation of our behavioural patterns, different habits and addictions, customs, traditions and faiths can simply be defined as culture.

Culture includes food habits, customs related to marriages and funerals, religious observances, ways of worshipping, etc. These features differ from society to society. Consequently, one culture can be distinguished from another.

## **Definitions presented on Culture**

There is no common definition presented on culture. Different anthropologists as well as sociologists have defined culture in different ways. Given below is one such famous definition.

'The culture is that complex whole which includes knowledge, belief, art, law, morals, custom and any other capabilities and habits acquired by man as a member of society.'

-E. B. Tylor-

The above definition proves the fact that culture includes all human activities. It makes people to be adapted to a common system of morals or it is the instrument which predominantly controls man. Therefore man cannot be controlled in the absence of some kind of a culture. The fundamental task of culture is to provide the strength needed to control human society in a formal manner. Culture teaches us do's and don'ts and guides us how to follow them. Study the following dialogue to have a better understanding of culture.

Grade seven subject teachers and class teachers of Namal Yaya Maha Vidyalaya decided to take their students on an educational field trip. It was arranged as a two day trip covering two historical cities, Anuradhapura and Polonnaruwa. Here is a part of the conversation that took place between the class teacher and a few students.

Dewni: When I left home in the morning, my mother asked me to visit all the eight sacred places in Anuradhapura and study the importance of them. She also asked me to describe them to her and father once I get back home.

Janutha: Is it so? Even though I have heard of the eight sacred places, even I do not know what they are. Let's ask our teacher.

Dewni: Teacher, will you tell us about the eight sacred places, once we reach Anuradhapura?

Teacher: Yes, children. I will explain you the importance of our trip

as well as the historical value of the places we are visiting.

That is why I asked you to bring a notebook and a pen.

Ansar : Teacher, do the eight sacred places belong to our culture?

Teacher : That's right. Very good. Hope you all listened to Ansar.

Ansar has already understood the facts by reading books. All artistic creations and tanks in Anuradhapura and Polonnaruwa are part of our culture. They are our cultural heritages. Not only Buddhists, but also Hindus have

contributed to these creations.

Devi : Teacher, I have heard that Shiva Devala in Polonnaruwa is

a construction of Hindus.

Teacher : Yes, there is a belief that Shiva Dewala dipicts Hindu

Culture.

Nimesh : Teacher, then is it only religions, stupas and wewa

belong to culture?

Teacher : That's also a good question. Not only those, culture

consists of customs and rights of people, belifs, food habits, clothing, ways of speaking and behavioural

patterns of the people.

Fathima : Teacher, are they common to all ethnic and religious

groups?

Teacher: No, you must understand this correctly. Every ethnic and

religious group has a culture. However their cultures differ from one another. But some cultural elements are

common to all of us. Do you know them?

Janutha: Teacher, I know.

Teacher : Well, then, tell them Janutha.

Janutha : Language, religion, arts and crafts, clothes and dresses

customs and rituals.

Dewni : Teacher, though these are common to all, the way they are

performed differs from group to group, in terms of their

ethnicity and religion, aren't they?

Teacher: Yes, Dewni, explain your idea, so that all your friends can

understand.

Dewni : See,.... clothes and dresses are common to all of us. But

Sinhalese wear osariya, Tamils wear saree, Muslim women wear saree and furdha. That is why I told that though there are common features, some differences

exist among them.

Teacher : Well, Dewni explained it with good examples. There can

be some others who still cannot understand. I will

explain further for them.

We have a culture. It varies from one ethnic group to the other. It also varies from religion to religion. Sometimes it may vary from area to area and from society to society.

Therefore one's own culture is known as cultural identity.

Hope you all understand. Everyone should take action to safeguard cultural identity which is always a good thing. Now you all know what cultural elements are. You also

know what cultural identity is.

Now let me ask a simple question.

Fathima : Teacher, is it a homework?

Teacher: No, you must answer it now itself. Let us give a clap to the

one who tells the answer first. Here is the question. Give a simple definition for culture and say it aloud so that all

can hear.

Nimesh: Teacher, culture means, not only the things we eat, drink,

wear, speak, behave and worship, but also our arts and crafts, customs, rituals and all such other activities.

Teacher : Very good. It is a better answer than I expected. Do you


understand it now? Others should also keep their

#### **Elements of culture**



#### Features common to all cultures

Ethnicity, religion, languages and occupation are a few factors that bring about differences between one culture to another. For example, Sri Lanka consists of many ethnic groups such as Sinhala, Tamil, Muslim, Burgher and Malay. It can be pointed out that every ethnic group has its own culture and cultural features inherent to it.

- Ethnicity
- Religion
- Language
- Occupation
- Life style

One culture differs from another culture. Based on the factors such as ethnicity, religion, language and occupation,. The ability to distinguish one culture from the other based on the above factors is known as cultural identity.

It is essential to identify this cultural identity when we live in a multi - cultural society. Identifying cultural features and respecting them and not condemning them should be of paramount importance in such a society. It will build a strong inter relationship among cultures. It will make a good society and minimize conflicts in the society.

## Cultural diversity in Sri Lanka

Sri Lanka is the best example for a multi - cultural society. Sinhalese, Tamil and Muslim communities have been living in this country with a strong brotherhood for many centuries. In addition to that Burgher and Malay communities have also been living together as Sri Lankan communities.


In terms of religions, Buddhist, Hindu, Islam, Christian and Catholic communities live together. Religious co-existence has been well maintained. Most of the religious places have become common sacred places for the people of all religions. For example, Kataragama Dewala, Nallur Kovil, Madu Church, Thalawila Saint Anne's Church, Adam's peak are some of those sacred places worshipped by all people in common. Devotees of all religions visit these places irrespective of their religious differences.

Sinhala, Tamil and English are the main languages in our country. It is commonly seen in our schools that, Sinhalese children speak Tamil and English fluently while Tamil children speak Sinhala and English fluently. It is a commendable and praiseworthy situation. It is also essential to learn to speak, and write the languages used in the country in addition to our mother tongue.

Thus, our society is known as a multi - cultural society because there are different communities, religious groups as well as different language users. It is essential to work peacefully and cooperatively in such a multi - cultural society. You all must have determination to live in such a society peacefully and with harmony.

In addition to these there are other occasions in which cultural features can be identified. For example, weddings, funerals, weaning ceremony, hair cutting, house warming ceremony, etc. Customs & rituals followed in those cultural festivals vary from community to community. It can also vary from religion to religion.

## **Cultural Heritages**

Every culture has cultural elements which are identified as cultural heritages. Customs and rituals; arts and crafts; can be given as examples for cultural heritages. It is a responsibility as well as a duty of all to preserve those cultural heritages and to pass them to future generations.

Protecting the cultural heritages is important for ensuring continuous existence of a culture. It helps developing pride about ancient heritages and protecting uniqueness and identity of a culture. Especially, religious and ethnic groups have their own identity. It can be protected only if the cultural heritages are preserved and handed over to the future generation.

People will be trained to respect other cultures, their customs, practices, arts and craft only if they protect their own cultural heritages. As a good citizen of a multi-cultural society, respecting and protecting other cultures, their heritages are of paramount importance for the co-existence in the society.

## Steps to safeguard cultural heritages

As examples shrines, dagoba and the irrigation system in the Anuradhapura and Polonnaruwa areas express the grandeur of Sri Lankan culture.

As a citizen, following steps can be taken to safeguard the cultural heritages.

- Creating awareness among people about the importance of safeguarding cultural heritage.
- Refraining from engaging in harmful activities against culture and Preventing those who harm it.
- Whenever one destroys the cultural heritages, the relevant institutions should be informed. Ex: Institutions such as Police, Department of Cultural Affairs, Department of Archeology




Figure 3.11 - Samadhi Statue

It is the responsibility of every citizen to protect cultural elements of each culture. By doing that we can easily pass down the existing culture to the future generations. It will also create pride and esteem in them. For example, temples, stupas, tanks, irrigation and other cultural elements expose the pride of Sri Lankan culture to the world.

We all have a legal as well as a moral bond to safeguard cultural heritages. This desire should evolve in our mind naturally and with out a deliberate effort. We must determine to protect cultural heritages archaeological as well as for their physical value, without destroying them for our personal benefits. Different rules and regulations have been enacted to protect them mainly due to their archaeological importance. You may have seen in newspapers, televisions and in other media, the

instances where people have destroyed these valuable cultural heritages for their temporary benefits. It is our duty and responsibility to raise a voice against such people. Through those actions, we can legally interfere for safeguarding cultural heritages.

Many cultural heritages have been accepted as world heritages. Unless they are protected the future generation will lose them.

We all are morally bound to safeguard cultural heritages. Legal bond as well as moral bond are essentially important. You have the right to raise voice against the destruction of cultural heritages which reveal our identity to the world. It is a morality based responsibility.

## Transmitting culture through the family

Family is the basic unit which transmit culture from one generation to the other. It passes elements of a culture to another generation. Mother, Father, elder brothers and sisters, grand Mother, Grand Father and the other relatives undertake the task of passing or entrusting the culture.

For example, Sinhala and Tamil New Year rituals such as boiling milk, consuming food, engaging in transactions, anointing with oil are done by the elders in the presence of children. It will train the children to follow the same rituals in the future too. Thus, the family contributes directly to transmit the culture to the future generations. In addition to that, the school, religious places, elderly people and neighbours also contribute to pass down the culture.




Figure 3.20 - Anointing oil

It is important to safeguard culture in order to build up national harmony. For example, it is important to respect other cultures while safeguarding one's own culture. Consequently suspicion, hatred, jealousy and any other hostile feelings will be eliminated. It will help to build up national harmony. Especially it will contribute to create "Sri Lankan" consciousness.

In a multi cultural society, living in coexistance while safeguarding cultural heritages of all the communities leads to the growth of national pride.

## Symbols that reflect National identity

Most of the countries in this modern world are multi - cultural societies. Many ethnic, religious and language groups live within the same country. This is known as a multi - cultural social system. Each group has its own unique identity which should essentially be protected by all. If not, there is the possibility of erupting hostilities and conflicts, among their groups.

In a multi-cultural society, if all citizens could work as united, collective, groups with social integrity it will help to build up national identity.

For example, if all the Sinhalese, Tamils, Muslims, Catholics and Christians and those who speak Sinhala, Tamil and English work with a "Sri Lankan" consciousness, it is called national identity.

Sri Lanka has several symbols which symbolize national identity. They are National flag, National anthem, National emblem, National tree, National Flower, National bird and National Sport.

## **National Flag**

National flag is conspicuous among all the other symbols which symbolize national identity. It has been designed on the basis of old royal flag used by King Sri Wickrama Rajasinghe. The national flag we use today in our country is also called the 'Lion Flag'.

The national flag we use today in Sri Lanka is a flag made under recommendations of the flag committee appointed on 6th March 1948 by Hon D.S. Senanayake who was the first Prime Minister of Sri Lanka. Members of the national flag committee were

- Hon. Sir John Kothalawala

Parliament passed the National flag prepared according to the proposals of the flag committee on the 2nd of March 1951. It was hoisted in the flag mast infront of the old Parliament on the 31st of March 1951. In 1972, traditional bo leaves which were in the flag were removed and the four bo leaves of the present day were added.

#### The symbols of the National Flag represents

**Yellow colour lion** – Sinhala nation, discipline of the Sinhala community. bravery, dignity and leadership, fairness of the nation.

Yellow colour sword held in the right hand – piousness, law abide while safeguarding the motherland by governing the country in fairness.

Four bo leaves in the four corners on a red background – respect for all the sublime qualities of all religions including the four sublime states of the mind, namely, loving kindness, compassion, sympathetic joy and equanimity.

**Dark red background (maroon)** – life blood of all the people of Sri Lanka and representation of the ancient Sinhala Royal flag.

Green and yellow columns on the left side of the flag – Tamil community represented by the yellow column, Muslim community by the green column.

**Yellow band of equal width around the flag** – unity among all the communities, peace, wisdom, and mutual understanding.

Mane of the lion head and bend in the upper part of the tail – equality between the ruler and the subjects.

Article 6 of the present Constitution of Sri Lanka refers to the National Flag and it is depicted in the Second Schedule.

"The National Flag of the Republic of Sri Lanka shall be the Lion Flag depicted in the Second Schedule."

The standard of the present national lag of Sri Lanka has been prepared by the Sri Lanka Standards Institute. The last amendment of our National Flag which was introduced on 22nd May 1972 was standardised by Sri Lanka standards institute on 7th May 1985.

Reference is also made to the proper design, dimensions and colours of the Sri Lanka National Flag as laid down in Sri Lanka Standard Specification SLS 693; 1985, was published by the Sri Lanka Standards Institute.

## The occasions in which the national flag is hoisted

- In state festivals
- In national festivals
- In state leaders' summits
- In an important function of a school or in an institution
- Other special functions.

## Factors that should be considered in displaying the national flag


- Hoisting it in a visible place
- Hoisting the flag by keeping the two vertical colour columns close to the flag pole
- Giving priority in all the functions and ceremonies
- When hoisting it with flags of other countries it should be placed in equal height / other flags should be placed on the left side of the Sri Lanka National flag /all the flags should be of equal size
- When hoisting it at night the respective place should have enough light
- When hoisting with regional flags, flags of societies, schools and committees the National Flag should be placed in the middle of them rising high above all of them
- When hoisting flags on several posts closely it should be raised up first and lowered finally
- Flag should be hoisted in a way that lion stands parellel to the ground when it is displayed in the middle of a street
- When the flag is used in processions (Perahera) it should be carried on the right
- When taken with other flags, it should be carried in the middle part of the front area
- When the national flag is diplayed at balcony or infront of a building, it should be placed at an angle of 45° and not horizontal.

## Rules to be followed when hoisting national flag in a ceremonial function

- Before hoisting it, the flag should be fixed to the cord and the folded flag should be kept at a higher elevation.
- The person hoisting the national flag should stand in attention and the others should also stand in attention facing the flag
- Hoisting and lowering the national flag should be done slowly with honour
- Playing Magul Bera (ceremonial drums) and blowing the conch shell whenever it is possible while hoisting
- After hoisting the flag everybody stands in attention and sings the national anthem

## Rules to be followed when placing the national flag at half mast

- It should be kept at half-mast only on special occasions as day of mourning declared by the government
- Initially the flag should be raised to the top of the flag post and lowered to the place where the flag is kept at half mast

• The flag should be lowered 1/3 of the height from the top. Before the flag is lowered at the end of the day it should be raised to the top again and then lowered

## Rules to be followed when hoisting the national flag educational institutions

- Hoisting at the begining of each school term and at the begining of months in each term
- Hoisting on special days declared by the government
- On special occations such as prize giving, and sports meet

## Things to be avoided when using the national flag

- · Displaying damaged and deformed flags
- Using for any form of decoration
- Displaying the lion upside down
- Flag in contact with the ground or dragging on water
- Using it as a garment or a cover
- · Keeping any symbol, picture, or drawing on the flag
- Using as a sportswear (A badge of the national flag can be stitched to the upper part of the dress of military, fire brigade, and police personnel)

#### **National Anthem**

National flag as well as national anthem symbolizes the identity of a nation. The national anthem in Sri Lanka is "Sri Lanka Matha Apa Sri Lanka Namo Namo Mathaa". It was composed by Mr. Ananda Samarakoon. Our national anthem was sung for the first time on the 4th of February in 1948 in the first Independence Day ceremony.

National anthem is important in creating an esteem, love, faith and respect in the minds of the citizens of the motherland. It creates a sense of equality since it represents all ethnic, religious and language groups in a country.

# **Background of making National Anthem in our country**

When it was about to gain independence a national anthem was not in use. Therefore the responsibility of selecting a national anthem by a competition was assigned to Lanka Gandharwa sabha. A Sinhala and Tamil panel of judges was appointed to consider the language and concepts of the songs received for the competition. The members in the panel were

This competition was held on the 31st of January 1948. Though the song "Namo Namo Matha" written by the musician Ananda Samarakon was also presented, the song "Sri Lanka Matha Pala Yasa Mahima Jaya Jaya" written by Mr. P. B. Ilangasinghe and Music edited by Mr. Layanal Edirisinghe won the competition. Accordingly, this song was sung at the first independence day celebrations held on the 4th of February 1948. As this song was compiled by two of the judges in the panel people protested and the song was deleted from usage. Thereafter the song composed by Ananda Samarakon "Namo Namo Matha" was sung as the National Anthem in the second independence day celebrations. On the 22nd of November 1951 the cabinet decided this song should become the National Anthem. Later the first sentence was changed as Sri Lanka Matha instead of Namo Namo Matha.

1978 constitution declares that the National Anthem of our country is "Sri Lanka Matha". Lyrics and the music composition has been included in the constitution as a schedule.

National Anthem of the Republic of Sri Lanka is "Sri Lanka Matha" The music and the lyrics of the national anthem is included in the third schedule.

The amendments in the national anthem should be done after passing the proposal in the parliament and the public approval is obtained through a referendum.

Lyrics of the national anthem is included in the front pages in all the textbooks provided to you free. It is your duty and a responsibility to pronounce the words accurately with the proper chords and sing it aloud. When it is sung, it should be honoured by standing at attention.

#### State emblem

State's emblem is the symbol of the state. It symbolizes the rule of the state. State emblem which is being used at present was introduced in 1972. The state emblem was designed in order to celebrate Sri Lanka becoming a Republic on the 22nd of May 1972. You have noticed that the emblem is being used to confirm the state ownership. Currency notes, letterheads of ministries and departments, passports, national identity cards are a few in which state emblem is placed. The ownership of the state emblem and the authority to use it belongs to the Executive President. It is our responsibility and duty to honour and protect it.

During the British Colonial Era, British Emblem with the Lion and the Unicorn had been in use. After the Independence, an emblem with the lion inside a circle of petal design, a crown on top and the word Lanka at the bottom was used.

The state emblem in use today was created by the artist named S.M. Senevirathne. The symbols used in the Emblem represent the following.

#### **National Tree**

National Tree of Sri Lanka is Ceylon Ironwood (Na tree). The botanical name of it is *Mesua ferrea L.M.* Ceylon Ironwood tree has been recognized as the National Tree of Sri Lanka from the 26th of February 1986.

There are several reasons to select Ceylon Ironwood tree as the National Tree. They are;

Being endemic to Sri Lanka

Usefulness

Historical and cultural importance

Beauty and the pleasantness

Availability around the island

Not being used as a State emblem in any other country

From time immemorial, Ceylon Ironwood tree has been worshipped with reverance. According to Buddhist literature, Buddhas named Mangala, Sumana, Revatha and Sobitha have attained enlightenment under the shelter of Ceylon Ironwood trees. There is a belief that Maithree Bodhisattva would attain enlightenment under a Ceylon Ironwood tree. It is believed that Gauthama Buddha on his first visit to Sri Lanka visited Mahiyanganaya and planted a Ceylon Ironwood tree.

# Names for Ceylon Ironwood tree in different languages

Sinhala - Na

Tamil - Naaha Maram (நாக மரம்)

English - Ceylon Ironwood

Hindi - Nagkeshar

Pali and Sanskrit - Naga

Ceylon Ironwood tree grows in the low wetlands and can be seen in abundance close to temples and shrines. It can also be seen planted along the roadsides for shelter.

The tender leaves of Ceylon Ironwood is pink in colour. Matured leaves turn to green colour. Though timber of the Ceylon Ironwood tree is very hard it is not used for construction purpose other than constructing temples and shrines. It is mentioned that timber of Ceylon Ironwood tree was used for constructing bridges and making ships in the past.

Ceylon Ironwood tree is of high medicinal value. Roots, bark, flowers, pollen, fruits, tender leaves, are used as drugs. Pollen of the Ceylon ironwood tree is used for making perfumes.

#### National Flower

National Flower of Sri Lanka is Blue water lily. The botanical name of it is *Nymphaea nouchali* Burm.f. It grows in marshy lands and in reservoirs. It is very soft light blue - purple in colour. It blooms when the sun rises and withers when the sun sets. It is a common feature when two or several plants of Nymphaea family be in the same water, they hybrid. Flowers bloom with variety of new features due to this and this makes the plant popular in landscaping.

# The background and importance of selecting the National Flower

There are several factors to select blue water lily as the National Flower. Among them the usefulness, cultural, historical, scientific and aesthetic value are important. In addition, being endemic and not being declared as a National Flower in any other country have also been considered.

Many had the opinion of selecting the Lotus as the National flower. This opinion did not come into light as the National Flower of India was also Lotus. Accordingly, Blue water lily was declared as the National Flower on the 26th of February 1986.

Blue water lily is significant in Buddhist literature, arts, poetry and in indegenious medicine. It has been called by different names such as *Indeewara*, *Nilupul*, *Niluppala*. Buddhist lore in Sri Lanka claims that this flower was two of the 108 auspicious signs found on Prince Siddhartha's footprint. Therefore, it is considered as an auspicious sign. Ancient poets mentioned that Sigiri maids (maidens in the frescoses) held Blue water lily and Lotus. In addition to that Sandesha Kavya (message poem) mention that ladies in the ancient times used Blue water lilies as their earrings. King Kashyapa the first had also named one of his daughters as Uppalawanna comparing her to a Blue water lily.

Blue water lily is of great medicinal value. Bulb, stem, stamen, seeds of the plant are herbs.

#### **National Bird**

National bird of our country is Ceylon Jungle Fowl. It is found in the jungles throughout the island.

It is an inherent feature of the Jungle Fowl to live in flocks. Fleeing into a higher place in the forest for protection at the slightest sign of danger is a nature of this bird. It makes sounds to communicate about the danger to other members. It may forage for grain, seeds, berries, buds, leaves and insects. It crows at dawn as a daily routine. The poets in the past have written many verses celebrating the sweet sound of the Jungle Fowl. Ceylon Jungle Fowl wander close to human habitats for food. It has significant behavioural patterns such as briskness, facing challenges without retreating, and working in co operation.

Close relationship between the Jungle Fowl and the Sri Lankan rural life is one of the reasons for selecting it as the National Bird. Briskness, outer appearance and being endemic to Sri lanka are few other reasons. It falls in to the category of threatened species. Catching, keeping them in possession, and killing them are punishable offenses. Therefore it is our duty as citizens to protect the bird as a national treasure.

### **National Sport**

The National Sport of our country is Volley ball. Earlier, an opinion was forwarded that Elle should be our national sport. However, due to problems in using Elle for international events, this opinion was changed. This game is important for improving qualities such as unity, participation, peace, tolerance in victory and defeat. This is often played in Sinhala and Tamil New Year Festival, School sport meets and sports clubs.

This was originated in 1885, in Holyoke USA. The credit goes to William G. Morgan as the founder of Volley ball. It was introduced to our country in 1916 by an American sports director named Robert Walter.

Playing as a team leads to the victory. It is very important that every player of the team to take the responsibility exclusively to bring victory. Furthermore, Volleyball has been selected as the national sport

of Sri Lanka as it has features such as the possibility for many to play together with less facilities and the popularity in the island.

# Identifying one's own cultural identity

Cultural elements which a group of people, by an ethnic or a religious group traditionally possess can simply be introduced as their own cultural identity. For example, Buddhists do not sit in equal heights when they sit with elders' and interrupt conversations of the elders as well. It is important to safeguard one's own culture without harming other cultures. We should not let down, criticize, blame or ignore the others' cultures. As one protects and honours the features of own culture, those of the others should also be protected and respected. It is the duty and responsibility of all good citizens. It creates mutual faith, dignity and coexistence among all cultural groups. Then a conflict free social environment evolves.

#### What are Morals?

Society is made of a totality of a human group. Whole society should be developed by improving moral values in each person. Morals are the set of good things accepted and followed by a society for a long period of time. Though they are not legally enforceable, they function as a device that controls and operates the whole society.

Morals are human qualities that enrich the person, society and life. They are essential to improve living conditions of people. These morals account for the formation of social relationships as well as a good society. Therefore, morals are human qualities which contribute to the existence of a good society and bring meaning to life.

# Need of morals for the wellbeing of society
